PCSO Nick Gough reports as follows:-

"The main focus for us at the moment is burglaries. We've seen an increase in North Somerset and have drafted in additional resources to deal with it.

• In response to our query regarding the width of pavement between Brockley Stores and the Brockley Lights Rob Thomson of NSC advises as follows "The footway is 1.22 metres wide at its narrowest point (1.32m if you include the top of the kerbstone) - this exceeds the necessary standard which is 1.2m. The path is generally 1.3m to 1.4m wide. Typical wheelchairs and double-buggies are about 0.65m wide, so there is enough room. The previous path was narrower, albeit set-back from the road behind the verge. "
