## **10. Highways, pavements, verges and footpaths**

### **a) General update – highways**

No update from Gregg Brake of NSC, although he has been asked for an update.

- It appears that there is some movement regarding the condition of the bus stop, wall, hedges and pavement on the A370 between Brockley and Backwell (Bristol bound). Update awaited.
- The bus stop opposite Brockley Stores has now been cleared of vegetation and pavement cleared.
- The ongoing issues with potholes was raised by EF who is to report those she is concerned about and provide Clerk with details. Clerk will also request Gregg Brake of NSC to look at issues in Brockley including St Nicholas Way which continues to be an area of concern.
- Our complaints regarding the BSIP work have been submitted and responses now received from Jo Walker, Chief Executive of NSC and also from Rob Thomson, Head of Infrastructure (BSIP) and both have been circulated. It is quite clear that, despite our concerns, there will be no change in the installation of the bus lanes on the A370 and/or the prohibited right turn into Brockley Lane. Apologies for the mistakes in communication and consultation have also been proffered.
- Although the complaint appears to have been closed, It was resolved that Clerk write to Jo Walker advising that BPC remains very upset with the outcome and feels that there was no intention of taking into account our objections and we remain concerned that there, seemingly, is no route to take this further. Proposed by EF and seconded by BS.

MF raised the issue of PCAA's concerns regarding the installation of 18 Ultra-Fast Vehicle Charging Points at the Airport. The Airport is requesting this as "Permitted Development" but PCAA considers that this should go to full planning. They are asking for response from Parish Councils and It was resolved to support their stance whilst adding that we do not really have strong feelings as it is difficult to predict impact. Clerk to respond accordingly. Proposed by BS and seconded by MF.
