2 members of the public raised the following concerns: -

- Issues arising from the Taylor Wimpey application in Backwell.
- Highway issues recent spate of accidents and speed limits on rural roads.

1 member of the public raised further issues: -

- Following a meeting they had with Rt Hon Liam Fox and have raised a number of issues with him, in particular, the damage to highways and also the issue of the Chelvey conservation area relating to likely new traffic movements due to the pending Taylor Wimpey application.
- Graffiti on the railway bridge near St Bridget's Church. Responsibility for maintenance is likely to be with Network Rail. Clerk will check with them.
- Flood adjacent to the waterworks site.

Members of the public thanked for their contributions and advised that all these issues are being considered and referred to NSC where appropriate.

We were pleased to welcome our new District Cllr, Tom Daw. Tom outlined some issues raised at the full NSC Council meeting on 9 January and has pledged to support Brockley in any way he can. He is already aware of highway and flooding issues and the threat of more development.

Our main concerns are the changes to Settlement Boundaries and Green Belt, of which we were not aware, and the removal of Bristol Airport from the Green Belt.

### 10. Highways, pavements, verges and footpaths

### a) General update - highways

Gregg Brake of NSC advises that he has travelled around the Parish and acknowledges the various issues.

- The edges and verges on the roads throughout the Parish are being destroyed due to
  increased traffic caused by the diversions. At the time Gregg was visiting much of this
  was also under water. Having liaised with Phil Bush of NSC contact has also been made
  with James Padgham (BSIP) to request that this is rectified from BSIP budget.
- Various flooding issues have been caused following recent heavy rain and it is clear that ditches in certain areas require attention.
- Clerk to also raise issues with Rob Thomson and Head of BSIP Infrastructure with District Cllr Tom Daw to be copied in.

### b) General update – footpaths

• The width of the footpath running from Brockley lights to Brockley Fruit Stores raised as a concern. It appears that this will be at the edge of the carriageway, and it must be wide enough to safely allow double buggies and mobility scooters to safely use it. Clerk to raise with BSIP.

- Chelvey Lane. Although not particularly deep water runs off into fields. There is an ongoing need to ditch clearance and 3 blocked drains also impact.
- Area around St Nicholas Church. Increasing frequency of flooding. Photos also available from St Nicholas News.

All these issues to be reported to NSC and copied to Tom Daw.
